## Rules & Regulations

**Raffle Sponsor:** United Heritage Charity Foundation, Austin, Texas.

**Ticket Sales:** United Heritage Charity Foundation raffle tickets are available for purchase online through UHCF.org, at any United Heritage Credit Union branch location during the official raffle period and at Howdy Honda on June 25, 2016 and the day of the drawing July 8, 2016 Fee is \$1.00 for each entry.

**Raffle Period:** Raffle begins start of business day Tuesday, March 22, 2016 and concludes end of business day Tuesday, July 5, 2016. Entries received online and through United Heritage Credit Union locations must be received by July 5, 2016. Entries received through the Howdy Honda location must be received by Noon on July 8, 2016.

**Eligibility:** Must be 18 years of age to enter/win. Must purchase a raffle ticket. Number of entries is not limited.
