Rules & Regulations

Raffle Sponsor: United Heritage Charity Foundation, Austin, Texas

Ticket Sales: United Heritage Charity Foundation raffle tickets are available for purchase at authorized agents including United Heritage Credit Union. United Heritage Charity Foundation raffle tickets are available for purchase at United Heritage Credit Union branch locations during the official raffle period. Fee is \$1.00 for each entry.

Raffle Period: Raffle begins start of business day Tuesday, March 26, 2019, and concludes end of business day Saturday, July 6, 2019. Raffle entries received through United Heritage Credit Union locations must be received by Saturday, July 6, 2019. Raffle tickets will be available for purchase the day of the drawing.

Eligibility: Must be 18 years of age to enter/win. Must purchase a raffle ticket. Number of entries is not limited. United Heritage Credit Union (UHCU) employees, United Heritage Charity Foundation and UHCU Board members, and their immediate families (in the same household) are not eligible.

Prize: 2019 Jeep Cherokee Latitude Plus FWD

Proceeds: All proceeds benefit charities supported through the United Heritage Charity Foundation.

Winner Drawing: Raffle entries must be received by July 6, 2019. The winner will be randomly drawn from all eligible entries received on or before Saturday, July 6, 2019.
